2. Scratching or cancelling of entries prior to the closing date will be refunded with a 20% admin fee-

SAEF, SASJ, SAEQA, DSA, SASA, SANESA, Highveld Equestrian Club nor FOREVER RESORT BADPLAAS, nor their representatives shall be held responsible for any loss, damage, theft, injury or death sustained by horses, riders, appointed officials, the public or their property. All persons participating at this event do so at their own risk and will have no claim against name of HEC Riding Club, SAEQA, SASJ, DSA, SASA, SANESA, Forever Resort Badplaas, MP Show Jumping, MP Equitation, MP DSA, MP SASA or the SAEF, including any officials, employees, members, affiliated bodies, show-holding bodies or sponsors, for any damage or loss of property or death or injury of persons suffered during or in connection with this event from any cause whatsoever. No minor may participate in this event without the permission of his/her guardian, who indemnifies all mentioned above against any such claims by such minors.

1. All SAEF, FEI, SASJ, SAEQA, DSA, SASA, Highveld Equestrian club and FOREVER RESORT BADPLAAS ground rules will apply. The Organizers reserve the right to cancel, combine or restrict classes should entries so warrant or according to prevailing circumstances.
2. **ALL MOUNTED RIDERS MUST WEAR HARD HATS.** As per FEI Article 256. 1.4, it is compulsory for all persons to wear a properly fastened protective headgear with a three-point retention harness at all times when mounted. Competitors shall wear the correct dress for competitions.
3. Any requests for a specific riding order **MUST** be emailed to the SHB. It is the competitor's responsibility to check whether their entries have been received.
4. The organizers reserve the right to restrict the number of entries accepted to a manageable number.
5. Any athlete not available to ride his/her test or class at the time allotted must contact the Show Organizers or Senior Judge to arrange for a new riding slot or they will be eliminated.
6. Incomplete entries and entries without proof of payment will be excluded & discarded
7. **Entries will NOT be refunded if withdrawn after the closing date of entries!**
8. Whilst every effort will be made to adhere to the scheduled as stated, the organizers reserve the right to change the program order in which the classes are ridden
9. Please take note that we will give only APPROXIMATE starting times for each class on the program. It is the rider's responsibility to be on time.
10. Please note an immediate jump-off may be used at the discretion of the judge and will be announced.
11. The organizers reserve the right to fine, warn, suspend and/or eliminate offenders. SAEF Rules regarding excessive use of whips will be enforced.
12. **The abuse of a horse will be strictly prohibited.**
13. **All stallions must have a yellow disc on both sides of the bridle or have a yellow ribbon in the tail. They must also have a yellow tag on their halter.**
14. Stallions remain the responsibility of the owners & riders at all times, and they are expected to have public liability against loss, injury or damage that might be caused by the stallion.
15. Equine Flu Vacs must be administered within 6 months + 21 days of the date of the event. No horse may compete in the 7 days after the vaccination.
AHS VACCINATIONS MUST BE IN ORDER
16. **All horses must have a valid SAEF passport available for inspection at any time.**
17. Horses from outside the AHS Surveillance area must have valid *AHS vaccinations (12 months)* and a *current Certificate of Movement*.
18. The athlete undertakes NOT to bring any horse/pony to the event that has an infectious disease, whether notifiable or not or which the athlete could reasonably be expected to know has an infectious disease or may spread same.
19. All Equines Microchips compulsory 2018
20. When, at a competition (or prior to a team's departure), the organizers or officials find that a horse/pony is unfit to compete and should a Veterinary Practitioner be called in to examine the said horse, the cost of this examination is to be borne by the owner or athlete.
21. It is the owner/ athlete responsibility to ensure your horse is supplied enough grass, water, and feed for the duration of their stay.
22. Horses are stabled at Highveld Equestrian Club at own risk. Health & care is entirely the responsibility of the owner/athlete.
23. Horses grooms are welcome to stay on the property to ensure the care of own horses. Horsebox parking, Toilets, showers and wash up are available.
24. Owners/ athlete take full responsibility for own groom's wellbeing.
25. Horsebox parking is available and at owners own risk.
26. Any owner or athlete who attempts to interfere with or influence the Judges, Stewards or Officials, or who at any time uses any contemptuous or abusive language to any of the Judges, Stewards or Officials may forfeit his/her rights to any prizes to which they might otherwise be entitled and may face other disciplinary action.
27. **All protests must be addressed to the ground jury in writing accompanied by a deposit of R400 for provincial classes. Within the required time period. No verbal protest will be accepted. Download the protest form on discipline websites.**
28. Dogs are NOT welcome at shows, but if they have to be there, they **MUST BE UNDER CONTROL AND ON LEADS AT ALL TIMES**. Fines of R50 WILL be imposed on the owners if dogs are found loose and proceeds will be donated to the charity of choice of the name of Highveld Equestrian Club
29. Any Rider / Horse fall must be reported to the Show Office. Rider / Horse injury report is required to be passed before the athlete is allowed to ride again in the class / next class or event.

The event will be run under SASA and SAEF rules unless otherwise stated.



1. Competitors may only ride one horse in each class, except in the Working Classes, where they may ride up to three horses.
2. All Riders and Horses must be registered with a Club, SAEF and SASA. For Membership see the SASA website www.showingsa.co.za or from admin@showingsa.co.za.
3. SASA will pay entry fees for SASA EDTS competitors in a maximum of 4 Ridden classes per day. The competitor must be an EDTS member of SASA. Membership is free. EDTS application forms, Rules and Conditions are available at www.showingsa.co.za or contact admin@showingsa.co.za for more information. EDTS competitors will earn EDTS Victor Ludorum points.
4. Working Hunters will be required to jump a course of approximately 8-12 fences, one of which will be a combination.
5. Should a competitor qualify more than one horse for the championship, he may nominate another rider, who must be a paid-up member of SASA, to show the horse in that championship. However, the competitor must do the individual test required in the Championship.
6. All classes will be run under SASA Rules Edition 26 effective 1st January 2026
7. EVERY COMPETITOR ENTERING THIS SHOW DOES HEREBY INDEMNIFY ANY JUDGE REGISTERED WITH SASA, OFFICIATING AT THIS SHOW, AGAINST ANY CLAIM OF ANY NATURE FROM ANY CAUSE WHATSOEVER.
8. Registered SASA Instructors will earn Victor Ludorum points for pupils.
9. Open Horses may be ridden by the Judge
10. Heights of Horses and Ponies must be stated in the SASA passport.
11. The minimum age of horses shown under saddle shall be 3 years.
12. All competitors, owners and sponsors shall be registered with a club in whose area of jurisdiction they have their principal place of residence, SAEF and SASA and shall be re-registered on 1 January each year. Membership forms may be obtained on the SASA website www.showingsa.co.za
13. Newcomers are open to riders who have never competed in graded classes in any age group. No cross entry with Graded Classes.
14. Horses shall be registered with SAEF and SASA.
15. The horse and rider combination will compete as a member of the province where the rider is resident.
16. All required vaccines and primaries must reflect in passport and be in accordance with SAEF
